lu1. General Terms and Conditions

1.1 These Terms and Conditions (hereinafter referred to as "Terms") govern the use of all games and services provided through www.betitall.bet (the "Website") and/or its associated downloadable applications (the "Apps"). By registering an account, the user enters into a legally binding agreement with the company upon acceptance of these terms. This agreement requires the user to adhere to all the rules and conditions outlined in this document. If you do not agree with these Terms, please refrain from using the Website and Apps. Continued use signifies your acceptance of these Terms. This agreement becomes effective immediately upon your acceptance.

1.2. By creating an account the user agrees to the terms, establishing a legally binding contract between the user and Velarion LLC.

1.3 The Website is owned by Velarion LLC, registration number: 3916LCC2024, registration address Suite 305, Griffith Corporate Centre, Beachmont, Kingstown, St Vincent and the Grenadines.

1.4 In these Terms, the following terms shall have the meanings assigned to them:

1.4.1. "Bet it All," "www.betitall.bet," "We," "Us," "Our," and "Management" refer to the company operating the Website and/or Apps.

1.4.2. "You," "Yours," "Customer," and "The Player" refer to the user of the Website and Apps.

1.4.3. "Games," "the Game," "Game," "Service," and "The Services" refer to any services offered through the Website and/or Apps.

1.5. Bet it All will use email to communicate with customers for marketing and notification purposes. Authentic communications will originate from domains ending in "@betitall.bet". Exercise caution if the sender's domain appears suspicious or contains unusual characters.

1.6. This version of the Terms is _____ and was last updated on _____, 2024. It remains in effect until a new version is published on the Website and/or Apps and accepted by you. Bet it All reserves the right to modify these Terms at any time for any reason. You will be notified of any changes prior to their implementation. If you do not agree with the updated Terms, you must cease using the Website and/or Apps.

1.7 By registering and using the Website and/or Apps, you acknowledge that you have read, understood, and accepted these Terms, as well as the Privacy Policy and individual Game Rules. These documents collectively constitute your agreement with Bet it All.

1.8 These Terms are available in multiple languages for informational purposes. The English version shall prevail in all cases and without exception in the event of any discrepancies between the English and non-English versions.

1.9. If a provision of this Agreement is or becomes illegal, invalid or unenforceable in any jurisdiction, that shall not affect the validity or enforceability in that

jurisdiction of any other provision hereof or the validity or enforceability in other jurisdictions of that jurisdiction of that or any other provision hereof.

1.10. Bet it All retains the right to assign this Agreement, in whole or in part, at any time and without prior notice. The User is not permitted to assign any of their rights or obligations under this Agreement.

2. Your Obligations

2.1. You can open only one account with Bet it All. If you open a duplicate account, Bet it All reserves the right to void all bets made from that account.

2.2 You must be at least 18 years old to participate. It is your responsibility to be aware of the legal age for online gambling in your country and to ensure that online casinos are permitted in your jurisdiction. Underage gambling is strictly prohibited and will result in criminal charges for the user.

2.3 You shall use your account solely on your own behalf and exclusively for recreational purposes. The games and services offered by Bet it All are intended for enjoyment.

2.4 At the time of this writing, you are prohibited from registering on the Website and/or utilizing our services if you reside in any of the following territories (Restricted territories):Australia, Austria, Comoros, France, Germany, Netherlands, Spain, United Kingdom, USA, all FATF Blacklisted countries.

2.5. Alongside the list of Restricted Territories, we also reserve the right to refuse service to customers from any other country.

2.6. Certain games from specific third-party providers will not be accessible in certain countries due to licensing and/or local regulations.

2.7. We implement technological measures to prevent individuals located in Restricted Territories from registering for an account and/or accessing or using the Services. You acknowledge and agree that we shall not be liable to you for any losses incurred as a result of your attempts to access the Website and Services from within a Restricted Territory, including through any means intended to bypass our controls or technological solutions that we will have in place from time to time to restrict or limit such access.

capture methods. Our measures involve, but are not limited to, analyzing device properties, geo-location detection, IP masking identification, and transactions and blockchain analysis.

2.11 Before utilizing the Service and on an ongoing basis, you acknowledge, affirm, and agree that:

2.11.1. You are fully responsible for reporting and paying any taxes and/or commissions applicable to you under the relevant laws for any winnings received from us.

2.11.2. You are solely accountable for any taxes that can arise from cryptocurrency awarded to you through your use of the Service.

2.12. The availability of our Services does not constitute an offer, solicitation, or invitation for the use of our Services in any jurisdictions in which such use is prohibited by law. If you use our Services in breach of any local, national, federal, provincial, state, or other laws that apply to you, we will not be liable to you for any consequences of such use. You are responsible for researching the laws applicable in your locality or country. You must ensure that you are complying with the law in the jurisdiction in which you are using the Website or any Service.

2.13. Before utilizing the Service and on an ongoing basis, you represent, warrant, covenant, and agree that:

a) You are at least 18 years old or of the legal age of majority as defined by the laws applicable to you, whichever is greater;

b) You possess full capacity to enter into a legally binding agreement with us and are not subject to any limitations on legal capacity;

To that end, the Service is not offered to individuals or entities subject to United States, European Union, or other global sanctions or watch lists. By using the Service, You represent and warrant that You are not so subject. The accessibility of the Website in any country or its appearance in the official language of any country shall not be interpreted as a representation or warranty regarding the legality of accessing or using the Website, nor concerning the making of deposits or the receipt of any winnings from your account. The availability of the Website does not constitute an offer, solicitation, or invitation by us for the use of or subscription to betting, gaming, or other services in any jurisdiction in which such activities are prohibited by law. It is your responsibility to determine the law that applies in the location in which you are present. You should ensure that you will be acting legally in your

jurisdiction in opening your account and/or using the Website and you represent, warrant, and agree that you will do so.

2.15 As a customer of Bet it All, you are held responsible to provide correct personal details like, but not limited to, personal data (passport, ID data), address, e-mail is completely true and up to date, and if there are changes to these details you would inform Bet it All immediately, before making a deposit. Concerning the errors in passport or ID data: up to three error symbols in the spelling of name and surname (three symbols in total) are allowed, only if it is not the first or the last letters. No mistakes are allowed in the date of birth. If it should become clear to Bet it All that the information provided is not correct, we retain the right to block the player's account and confiscate all the funds on the account therein.

2.16. You are permitted to use funds from legal sources when engaging with Bet it All's games and services. Bet it All reserves the right to block any customer and confiscate all funds in the account if there is reasonable suspicion of involvement in fraudulent activities, including, but not limited to, providing counterfeit, stolen, or misappropriated documents or personal data, using stolen payment methods, collusion, or chip dumping.

2.17. You understand that participation in Bet it All's games and services carries a risk of losing funds. We shall not be held responsible or liable for any circumstances arising from your participation in a game if you have not fully comprehended the Game Rules and/or the manner in which the game operates.

2.18. You acknowledge that engaging with the Services involves a risk of financial loss. By utilizing our Services, you accept full responsibility for any losses incurred. You agree that your use of the Services is entirely at your own discretion and risk, and you will not have any claims against Bet it All under any circumstances. If you do not accept this risk, we strongly advise against using the Website and/or Apps.

2.19 You acknowledge that only credit cards and financial instruments issued legally by recognized financial institutions can be used for deposits and withdrawals on the Website and/or Apps.

2.20 You will use the Website and/or Apps solely for personal, recreational use in accordance with these Terms and Conditions and all applicable laws, rules, and regulations.

2.21 You agree to communicate with Bet it All employees in a respectful and formal manner. Any abusive behavior toward Bet it All staff will not be tolerated, and Bet it All reserves the right to terminate its relationship with any customer under circumstances deemed appropriate.

2.22 When contacting Bet it All Customer Support at support@betitall.bet and Security Department at security@betitall.bet, ensure that your message is directly addressed to these addresses and not forwarded or sent as a carbon copy (cc). Such emails will be directed to spam folders, and therefore might not be viewed by the relevant department, especially concerning account closure or gambling issues. 2.23 If you qualify as a Politically Exposed Person (PEP), you are obligated to report this status to Bet it All Customer Support and to cease using Bet it All's games and services immediately. A PEP is defined as an individual holding a significant public office (or who has held such an office within the past year) and includes identifiable family members and associates. Failure to report this status will result in the suspension of your account and the confiscation of funds. A detailed review of your account will be conducted, during which time your account will be inaccessible. Bet it All reserves the right to discontinue offering games and services to you following the investigation.

3. Your Account

3.1 To participate in the games and Services offered by Bet it All, you must open a personal account.

3.2 Your account must be registered in your own correct name and personal details. It shall only be issued once to you and will not be duplicated through any other person, family member, household, address (postal or IP), email address, access device, or any environment where access devices are shared (e.g., schools, workplaces, public libraries). Creation of the account is solely for personal use, and acting on behalf of another person is strictly prohibited. If you notice that multiple accounts have been created, it is your responsibility to inform Bet it All immediately. Any additional accounts that you create or beneficially own in relation to the services will be deemed "Duplicate Accounts." Bet it All reserves the right to close any Duplicate Account at its discretion. Bet it All will assess whether multiple accounts have been registered due to error or misconduct. Should Bet it All have reasonable grounds to suspect that fraud has occurred, it reserves the right to block your account and confiscate any funds therein. The use of VPNs, proxies, TOR, or similar programs is strictly prohibited. If you access the Website or games from a restricted country using these programs, your account will be blocked. 3.3 You must complete a registration form to open an account at Bet it All. By doing so, you confirm that the information provided is correct, complete, and up to date. Bet it All conducts verification procedures on its customers. If Bet it All suspects that any information is misleading, false, incomplete, or compromised in any way, it reserves the right to impose restrictions on your account. You are responsible for updating your information via the "My Details" tab if such information changes.

3.4 After opening your account, you must take all reasonable steps to avoid disclosing your username, password, and/or account number to anyone, including ensuring that up-to-date security software is installed on your access device.

3.4.1 All transactions made using your username and password and/or account number will be regarded as valid, whether or not authorized by you. Bet it All will not be liable for any claims arising from the disclosure of your username, password, or account number to third parties. 3.4.2 If you have lost or forgotten your account details, or have reason to believe that such details are known to an unauthorized third party, you must contact Bet it All immediately for a replacement at support@betitall.bet.

3.5 If you provide incorrect or incomplete personal details (e.g., name, surname, date of birth, phone number, or address), we will be unable to verify your account fully. The Security Department will correct minor errors (up to three letters) in your name or surname, provided that the first or last letters are not affected. In the case of mistakes in the date of birth, only one digit will be corrected. If you realize that you have provided incorrect or incomplete details during the registration process, you must contact Bet it All immediately, prior to depositing or placing any bets.

3.5.1 If you have recently moved or your address has changed from the one listed in your profile, you must notify Bet it All at security@betitall.bet before making a deposit or placing any bets, providing documentation to verify your new address. Failure to do so will result in your last deposit being returned, your winnings being confiscated, and your account being blocked.

3.5.2 If the Security Department is unable to fully verify your account, authorize your personality or has reasonable suspicions of fraudulent activity, your winnings will be voided, and your account will be blocked.

3.5.3 In certain cases, the Security Department reserves the right to request video verification. If you fail to complete the video verification within seven days from the request date, Bet it All reserves the right to block your account and confiscate any winnings. However, this timeframe can be extended upon request if you are dealing with civil matters that prevent you from obtaining the required documentation (up to six months).

3.6 As part of your registration at Bet it All, you must provide information including, but not limited to,a mobile phone number. Bet it All will never request your account password. It is your sole responsibility to keep your account password safe and secure. Bet it All is not responsible for any misuse of your account, intentional or accidental, if your login details are disclosed to third parties.

3.7 Bet it All reserves the right to conduct security checks on your account at any time, during which the following documents will be requested: (a) proof of identity, (b) proof of address, (c) a colored photo of your payment card, and (d) statements of the payment method used. Bet it All will limit your account during the verification and/or investigation process and will request a selfie with your ID or passport if you are unable to submit documents within two days.

3.8. We shall not be liable or held responsible for any abuse or misuse of your Bet it All Account by third parties resulting from your disclosure of your login credentials, whether this disclosure was intentional, accidental, active, or passive.

3.9. We shall not be liable for any loss or damage that you will incur as a result of unauthorized access to your account.

3.10 Bet it All reserves the right to close, refuse, or block any account at its sole discretion without providing reasons to the Player. This right may be exercised in the event of a violation of any terms of this agreement, any suspicion of fraudulent activity, or any breach of international anti-money laundering regulations.

3.11 You have the right to close and/or suspend your account at Bet it All at any time by contacting the Security Department via email. Closing your account does not permit you to create a new one. To renew your contractual relationship with Bet it All, your closed account must be reopened by informing Customer Support via email, chat, or phone. If your account was closed due to any form of gambling exclusion, it must remain closed for the duration of the exclusion. Any additional accounts created will be subject to the terms laid out in these Terms and Conditions.

3.12 If you close an unverified account with an active balance, you remain responsible for completing your identity verification; otherwise, we will not be able to process any withdrawals from your account. If you fail to pass the verification, the casino will return your last deposit only if the amount does not exceed the active balance in your account.

3.13 Customer Support cannot impose any blocks and/or restrictions for longer than one week. To limit, exclude, or block your account at Bet it All, you must send an email to security@betitall.bet, including your name, surname, mobile phone number, reason for the account limitation/exclusion/block, and preferred time frame. If your account is blocked (whether permanently or temporarily), the Customer Support cannot accept deposits, process withdrawals, or complete any part of the verification process, nor perform any other actions related to your account. If your account is not yet verified, please include an ID document in your email to add it to your user file.

3.14 If you request to block your account for any reason and the balance is less than the amount of your last deposit, the remaining balance will be returned to your last payment method. If your account balance exceeds the amount of your last deposit, any winnings will be canceled, and the amount of your last deposit will be returned to your last payment method.

3.15 Security Department cannot impose any blocks and/or restrictions on users' accounts at other online casinos.

3.16 Security Department cannot impose any blocks and/or restrictions on users' accounts that are not registered on betitall.bet.

3.17 Customer Support and Security Department will not follow any specific blocking instructions or patterns provided by the customer.

3.18 All communication between Bet it All and the customer will be stored for a duration deemed appropriate by Bet it All.

3.20 You acknowledge and accept any limitations and/or restrictions on the accessibility of Bet it All's games and/or services due to legal reasons imposed by individual game providers.

Deposits can be made at any time using debit cards, e-wallets, prepaid cards, vouchers or direct bank transfers. Bet it All does not accept cash cheques and reserves the right to decline certain currencies and/or payment methods without prior notice.

5.2. By depositing funds into your account, you agree to use those funds for the following purposes:

- Funds are attempted to be withdrawn to a Revolut account.

6.12 If a player requests a withdrawal without meeting the minimum turnover requirements, Bet it All reserves the right to impose a 15% fee on the withdrawal amount. This fee will be deducted immediately upon approval of the withdrawal request by our Finance Department.

6.13.1. Minimum Turnover Requirements:

Slot Games: 3 times the deposited amount.

Crash/Fishing/Dice Games: 6 times the deposited amount. Sports Betting: 6 times the deposited amount.

Live Games: 6 times the deposited amount. Only bets or expresses with odds (coefficient) of 1.8 or higher will count towards the turnover requirement Blackjack and Baccarat: 15 times the deposited amount.

Only sport bets or accumulators with odds (coefficients) of 1.8 or higher will contribute to the turnover requirement.

6.14 While Bet it All will strive to accommodate your requests regarding the payment method and currency for your withdrawal, such requests cannot be guaranteed. Withdrawals will be processed through a different payment method than requested, including via different payment providers, bank drafts, or wire transfers (associated charges will be disclosed on the Website). In some cases, the currency of your withdrawal will differ from that of your deposit or request, and any necessary currency conversion will be conducted at Bet it All's discretion.

6.15. Bet it All reserves the right to impose a fee on withdrawals at its discretion. Additionally, you are encouraged to verify whether the payment method you utilize incurs any extra charges. Bet it All shall not be liable for any commissions or processing fees imposed by third parties, such as your bank, as these are beyond our control.

7. Bonuses

7.1 A single deposit of at least EUR 10, USD 10, AUD 10, CAD 10, RUB 1,000, BRL 50, MXN 200, TRY 300, UAH 400, or NOK 100 will trigger the bonus.

7.2 Bet it All reserves the right to modify, remove, or add any bonus available in a customer's account that has not been claimed. Any claimed and active bonus will not be removed under regular circumstances. If you selected a bonus upon making a deposit but did not receive it, refrain from placing any bets and contact support to manually credit the bonus. Please note that bonuses can only be credited to an intact balance. Bet it All reserves the right to disable any user account from bonuses, loyalty systems, or cashback.

7.3 Bonuses will be subject to wagering requirements, which will be displayed clearly before you decide to use a bonus. Withdrawals will only be permitted from the real money balance; any bonus money balance will be forfeited upon withdrawal. Bet it All reserves the right to determine which games and services contribute to wagering requirements. The minimum wagering requirement is 25 times the amount of the bonus plus the real money sum contributing to the bonus.

7.4 If a player activates a deposit bonus and begins placing bets, the player must fulfill the wagering requirements for both the deposit that activated the bonus and the bonus itself. Failure to complete the wagering requirements will result in Bet it All withholding winnings exceeding the deposit.

7.5 Different games contribute varying amounts toward wagering requirements, as outlined below:

- a) **Slots:** 100%
- b) All Blackjack and Baccarat Games: 20%
- c) Other Live and Table Games: 50%
- d) **Sportsbook:** 50%
- e) **Crash/Fishing Games, Scratch Cards, Dice, and Mines:** 0% Note: The provider Amusnet Interactive is excluded when playing with a bonus. Slots with RTP of 97.5% or higher: 0%

7.6 Bonuses are limited to one per person, phone number, address, shared PC, and IP address. Free Spins must be wagered with a minimum requirement of x45 on the winnings. Players must activate free spins while the bonus is active; any winnings accrued after the bonus expires will be revoked.

7.7 A "*No Deposit Bonus*" will be credited manually or automatically without requiring a deposit for activation. Certain restrictions apply:

- a) The maximum amount that can be won or withdrawn from any "No Deposit Cash Bonus" is 10 times the value of the bonus funds. For example, if a "No Deposit Cash Bonus" of €50 is received and the customer wins €1,000, the maximum withdrawal allowed is €500 (€50 x 10).
- b) For"*No Deposit Bonus"* in the form of Free Spins, the maximum amount that can be won is €50 or equivalent in other currencies.
- c) The cash bonus for leveling up is also considered a "*No Deposit Bonus*".

All conditions are mandatory when using any "No Deposit Bonus".

- 7.8 To receive a "*No Deposit Bonus"*:
 - a) Provide your profile data completely.
 - b) If your account matches with any other accounts, the bonus will not be available.
 - c) To withdraw winnings, you must make a minimum deposit and complete verification.
 - d) The maximum allowed bet during bonus wagering is €3 or equivalent in other currencies.

7.9 Is forbidden to purchase bonus games / game extras / reel re-spinning feature / double up / "gamble" / in slots if you have an active bonus at Bet it All because max bet allowed for an active bonus will be exceeded. If a player is betting more than allowed per bet with an active bonus, it classifies as bonus abuse. This type of game-play is only allowed with special agreement.

7.10 Bet it All reserves the right to impose restrictions on bonuses for customers from certain countries for undisclosed reasons. We further reserve the right to offer specific bonuses to individual customers or groups and to terminate, change, or alter these offers without explanation or compensation.

7.11 Bonuses are not available to residents of Ukraine, Russia, and Croatia.

7.12 Bonus hunting is strictly prohibited with any active bonuses (*Welcome, Reload, Special, Streamer bonuses, etc.*). Bonus hunting involves collecting bonus features such as free spins in online slots or bonus savings and then closing and reopening the slot after completing the wagering process. This type of gameplay is not allowed unless specifically authorized by management. Conditions for

streamer/affiliate/individual bonuses must be discussed individually, as the general terms do not apply to these bonuses. If a streamer or affiliate violates the terms of individual or affiliate bonuses, management reserves the right to revoke those bonuses.

7.13 If you cancel an active bonus, you will forfeit all bonus money. Upon making a withdrawal, all active bonuses will be canceled, and bonus money will be lost during the withdrawal process. All bonuses at Bet it All are sticky; all bets are made from the real balance, and all winnings are credited to the bonus balance. Bonuses must be wagered within three days, or the bonus balance will be canceled. Support Department cannot credit you again with a bonus you have canceled.

7.14 If any violation of these rules is considered an attempt to cheat the casino, Bet it All reserves the right to confiscate all winnings and deposits without the possibility of return.

7.15. We reserve the right to determine, at our sole discretion, the minimum and maximum betting amount, which will be clearly displayed on the Website prior to your placement of a bet count.

7.16. If Bet it All suspects that a Player is exploiting or attempting to exploit a bonus or any promotional offer, or if the Player is likely to benefit from any policy of Bet it All through abuse or a lack of good faith, Bet it All reserves the right, at its sole discretion, to deny, withhold, or revoke any bonuses or promotions from that Player. Additionally, Bet it All will terminate the Player's access to the Services, the Software, and/or temporarily or permanently block that Player's account.

8. Loyalty

8.1 The current coefficient for the player's loyalty level is fully credited in the following games:

- a) Slot Machines: 100%
- b) All Other Games: 100%

8.2 The current coefficient for the player's loyalty level applies differently in certain games:

- a) All Blackjack Games: 10%
- b) All Roulette Games: 10%
- c) All Baccarat Games: 10%
- d) Video Poker: 0%
- e) Punto Banco: 0%
- f) Oasis Poker: 0%

- g) Texas Hold'em Poker: 0%
- h) Casino Hold'em: 0%
- i) Live Dealer Games: 10%

8.3 A level-up bonus will be automatically credited to your account if there are no active bonuses.

8.4 Bet it All management reserves the right to revoke a player's loyalty level and associated benefits in cases where the player abuses the loyalty system, bonuses, or tournaments.

8.5 Bet it All management reserves all rights to take away client's loyalty level and benefits in cases when a client abuses loyalty system, bonuses or tournaments.

9. Idle and Inactive Accounts

9.1 Bet it All considers a customer's account to be idle when there has been no activity for a period of twelve (12) months, provided the account has a real money balance. Once an account is flagged as idle, Bet it All reserves the right to charge a monthly maintenance fee of \notin 20.

9.2 Maintenance fees for idle accounts are charged automatically. Each time a fee is deducted from the customer's account, an email notification will be sent to the customer's registered email address to inform them of the transaction.

10. Tournaments

10.1 Bet it All reserves the right to exclude a player's account from participating in tournaments and to confiscate all winnings if the player abuses bonuses and/or the loyalty system. This includes instances where the player is suspected of fraudulent activities involving tournament points or gaining an unfair advantage over other participants.

10.2 Bet it All will not pay out winnings from tournament participation if the player has been permanently blocked.

10.3 Wagers placed on Blackjack, Roulette games, and games from Evolution Gaming do not contribute to tournament eligibility.

10.4 Winnings earned in the "*Drop and Wins*" tournament from Pragmatic Play are automatically credited to the player's real money account.

11. Cookie Policy

11.1 Bet it All is committed to creating a fun and enjoyable environment for its customers. To deliver games and/or services tailored to each customer, personal data must be collected. By using the Website and/or Apps, you consent to Bet it All collecting your personal data. Bet it All will protect this data in accordance with our Privacy Policy, which is available on the homepage of the Website and the home screen of the Apps.

11.2 The customer acknowledges that Bet it All collects small pieces of data from the browser used to access the Website and/or Apps, commonly referred to as

"cookies". Personal information is treated as strictly confidential and will only be used when necessary. The information collected will be utilized for purposes including, but not limited to, bonus offers, promotional SMS and phone calls, and marketing emails. All customer accounts, regardless of whether they contain funds, will receive such information.

12. Exceptional Circumstances / Aborted Games

12.1 Bet it All reserves the right to cancel bets and issue refunds to players in the event of unexpected issues or circumstances outside its direct control, including but not limited to technical problems with third-party services and/or game providers, internet connection issues experienced by the customer, and hardware, software, or equipment failures on the customer's end. Bet it All accepts no liability for failures beyond its control.

12.2 Bet it All retains the right to void large bets that are suspected of being placed to exploit the offerings and/or services.

12.3 In cases where a bet or service is interrupted (for example, a loss while playing roulette), customers will request a refund by contacting customer support. Refunds will be credited to the customer's account no later than 48 hours after a decision has been made.

12.4 If a customer has an unused balance, they can request a refund by submitting a request to customer support. The request must include the customer's name, surname, date of birth, email address, and the amount requested for refund. Additionally, the customer should provide an invoice or bank statement for the payment associated with the refund request. Refunds will be processed within 48 hours of the decision, keeping in mind that Bet it All has payout limits that will affect the refund process.

12.5 If a bonus has been incorrectly credited to the customer, Bet it All reserves the right to amend the bonus or the customer's balance to correct the mistake. If a bet, game, or service contains a bug or any inaccuracies, Bet it All also reserves the right to make necessary corrections to the bonus or balance.

12.6 Bet it All shall not be liable for any downtime, server disruptions, or unexpected interruptions to gameplay and/or service access. Furthermore, Bet it All assumes no responsibility for connection issues, delays, or other operational obstacles that will result in partial or complete inaccessibility of the Website(s) and/or App(s) and their content. Refunds are considered on a case-by-case basis, subject to management's positive decision.

12.7 Bet it All strives to ensure that its Website(s) and/or App(s) are available for use twenty-four hours a day. However, Bet it All accepts no liability for unavailability during any period. Bet it All reserves the right to modify the content of available games and/or services on the Website(s) and/or App(s), perform maintenance work, update the system, or make any other necessary technical or software changes at the discretion of management. 12.8 Bet it All expects customers not to exploit errors on the Website(s) and/or App(s). If a customer becomes aware of any discrepancies, they should refrain from taking advantage of them and inform customer support immediately. Customers who exploit errors and fail to report them in a timely manner will be held liable, and Bet it All reserves the right to seek compensation for any losses incurred as a result of breaching this provision.

12.9 Each bonus game activation in a slot has an expiration period of 24 hours. Any unused portion of the bonus game, including rewards and progress, will be forfeited at the end of this duration.

13. Service Availability

13.1 Bet it All has no control over the telecommunications networks and internet access services necessary for you to access and utilize the Service. Consequently, Bet it All shall not be held liable for any outages, slow connections, capacity limitations, or other issues related to these services.

14. Customer Support

14.1 Customer experience is of paramount importance to Bet it All. We recognize that customers will have various inquiries and concerns that need to be addressed promptly. In cases of uncertainty, general questions, or complaints, visitors and customers can reach out to us through the following channels:

- Live Chat: Please refer to the "Support" section.

14.2 When contacting Bet it All's customer support, customers are expected to refrain from abusive communication:

- Using sexually offensive language.
- Making statements that directly or indirectly incite hatred.
- Abusing, harassing, or influencing customer support in a manner that causes distress, inconvenience, or insecurity to Bet it All Support Department.

14.3 Bet it All maintains a zero-tolerance policy towards abusive communication. Customer accounts flagged for abusive behavior will be subject to banning, deletion, inactivation, or any other actions necessary to prevent their use of the Website and/or App.

15. User Conduct

15.1 All users are expected to engage in respectful and constructive communication.

15.2 Should Bet it All determine, at its sole discretion, that your conduct—whether through live chat, email, or any other means—has been abusive or derogatory towards any employees of Bet it All, its affiliates, or third-party service providers, Bet it All reserves the right to suspend or terminate your Bet it All Account.

16. Complaints

16.1 Bet it All acknowledges that misunderstandings and unsatisfactory experiences will occur from time to time. Customers are encouraged to contact Customer Support if such situations arise.

16.2 When filing a complaint, customers should clearly address the issue, provide as much detail as possible, and include identity credentials to facilitate timely processing. Bet it All's Customer Support accepts complaints only in English; submissions in other languages will be disregarded.

16.3 Any claim related to a transaction must be submitted within three months following the transaction, payment or settlement date. Bet it All reserves the right not to acknowledge claims submitted after this period. Once a claim is received and accepted, Bet it All will address it accordingly. The outcome of the claim will be communicated to the customer via email, SMS or phone. The decision made by Bet it All is final.

16.4 If a customer is dissatisfied with the resolution provided by Bet it All and wishes to escalate the matter, they can contact complaints@gaminglicences.com to file a further complaint or dispute.

17. Intellectual Property Rights

17.1 Bet it All is the sole owner of the trademark "Bet it All" and the associated "Bet it All" logo. Any unauthorized use of the "Bet it All" trademark or logo will result in legal action.

17.2 The URL <u>www.betitall.bet</u> is our official resource locator. Unauthorized use of this URL on any other site or digital platform is prohibited without prior written permission from Bet it All. Links to www.betitall.bet will only be included on other websites with written consent from Bet it All.

17.3 Bet it All is the licensee of the rights to the technology, software, and business systems utilized within the Site.

17.4 The contents and structure of the Bet it All Website including text, code, graphics, files, and links, are protected by copyright and are the property of Bet it All. The content of Bet it All should not be copied, duplicated, or reproduced in any form without a written agreement between the user/beneficiary and Bet it All. Registration as a customer does not grant any rights to Bet it All's intellectual property.

18. Limitation of Liability

18.1 The customer participates in games and/or uses the services of Bet it All at their own sole option, risk, and discretion. The games, services, Website and/or App are provided without any warranty, whether express or implied.

18.2. Without prejudice to the generality of the preceding provision, the operators, including their respective directors, employees, partners, service providers, agents, and affiliated entities:

- Do not warrant that the software of the Website and/or App is fit for any particular purpose;
- Do not warrant that the software, Website and/or App are free from errors;
- Do not warrant that the games, services, Website and/or App will be accessible at all times without any lags and/or interruptions;
- Shall not be liable for negligence, loss, damage, expenses, or any direct, indirect, special, incidental, or consequential damages arising in connection with the customer's use of the Website and/or App or participation in the games and/or services of Bet it All.

18.3 The customer agrees to hold the operators, their directors, partners, agents, affiliated entities, employees, and service providers harmless from any expense, negligence, loss, damage, claims, and liabilities arising from the customer's use of the Website and/or App or participation in the games and/or services of Bet it All.

18.4. The company shall not be liable for events that are beyond its control ("Events Beyond Our Control"), such as changes in legislation, technical failures, or tax obligations, which remain the responsibility of the user.

18.5. We shall not be liable to you under these General Terms, nor do we have a duty of care towards you, regarding our adherence to or failure to comply with any regulatory obligations that will apply to us from time to time, including those related to responsible gambling or social responsibility.

18.6. You shall indemnify Bet it All and its affiliates for any costs, charges, or losses incurred, including direct, indirect, or consequential damages, loss of profit, and reputational harm, resulting from any fraudulent, dishonest, or criminal activities you engage in while using the Website and/or Services. Such indemnification shall be payable upon demand.

18.7 Under no circumstances, including negligence, shall Bet it All be liable for any special, incidental, direct, indirect or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use (or misuse) of the Service even if Bet it All had prior knowledge of the possibility of such damages.

18.8. Nothing in this Agreement shall exclude or limit Bet it All's liability for death or personal injury resulting from its negligence.

19. Breaches, Penalties, and Termination

19.1 If the customer breaches any provision of these Terms and Conditions or if Bet it All has reasonable grounds to suspect a breach, Bet it All reserves the right to close the account, restrict usage, deny the opening of a player account, and withhold any associated funds.

19.2 The decision made by Bet it All is final in cases of breach of these Terms and Conditions or any misconduct resulting in the suspension, limitation, or permanent restriction of the player's ability to participate in the Website and/or App..

19.3 If Bet it All deems a violation of the rules to be an attempt to cheat the casino, it reserves the right to confiscate all winnings and deposits without refund.

19.4. Arbitrage betting, which involves exploiting differences in odds or betting lines among various bookmakers to guarantee a profit, is strictly prohibited. Any winnings derived from such activities will be deemed invalid, and your account will be suspended, with the confiscation of any illegitimate winnings. Compliance with this policy will be monitored by our provider, Digitain.

19.5 If you have access to confidential information pertaining to an event or that could affect the outcome of a bet, you must not place bets on any event governed by the relevant sports or event governing body. Specifically:

- a) If you are an athlete, coach, manager, owner, referee, or anyone with significant authority to influence the outcome of an event, you are prohibited from betting on any event overseen by the respective sports governing body.
- b) If you are an owner (defined as an individual holding a direct or indirect legal or beneficial ownership of 10 percent or more) of a sports governing body or a member team, you will not bet on any events managed by the sports governing body or any events involving a member team of that governing body.
- c) If you are involved in a sport or event, you are not permitted to participate in setting betting odds for competitions in which you are involved.

19.6. In the event of a breach of any of the representations, warranties, or covenants mentioned herein, Bet it All reserves the right to close or suspend your Bet it All account at its discretion and void any bets to the extent permitted by law.

19.7. Attempts to contest the licenses of betitall.bet within the EU for the purpose of recovering lost funds will be deemed actions taken in "bad faith," which will result in account suspension and the reimbursement of losses incurred by the company.

19.8. Bet it All shall be entitled to close or suspend your Bet it All Account if:

- a) Bet it All considers that you are using or have used the Website in a fraudulent or collusive manner or for illegal, unlawful, or improper purposes.
- b) Bet it All considers that you are using or have used the Website in an unfair manner, have deliberately cheated, or taken unfair advantage of Bet it All, its third-party providers, or any of its customers, or if your Bet it All Account is being used for the benefit of a third party.
- c) Bet it All is requested to do so by any applicable law enforcement authority, regulatory authority, or court, or if Bet it All is unable to verify your identity, location, or source of funds as required to comply with its legal obligations.

- d) You are in breach of these Terms, the applicable regulations (including those applicable in your jurisdiction), or the fair use of our services.
- e) Bet it All has reasonable grounds to suspect that you are a compulsive problem gambler without being self-excluded.
- f) Bet it All considers that any of the events referred to in the preceding bullet points will have occurred or are likely to occur.

19.9. In the event that we close or suspend your Bet it All Account, you agree that, to the extent allowed by applicable laws, you will be responsible for any and all claims, direct losses, liabilities, damages, costs, and expenses incurred or experienced by us (collectively referred to as "Claims") that arise as a result. Additionally, you shall indemnify us upon request for such Claims, as permitted by applicable laws.

19.10. Under the circumstances outlined in this section, we reserve the right to void any bets placed by you subsequent to such actions. We will also withhold and/or retain any and all amounts that would have otherwise been paid or payable to you, including any winnings.

19.11. To ensure fair play for all users, you are prohibited from employing any new or recognized betting strategies on our Website that aim to bypass the standard house edge in our games. If we determine that you have engaged in such practices, we will promptly suspend, terminate, or restrict your access to your Bet it All Account and/or retain any remaining funds in your account.

19.12. We retain the right to suspend or terminate your account at any time, with or without prior notice, if we believe that your Bet it All Account has been compromised or is being utilized in violation of our Terms of Service.

19.13. If we close your Bet it All Account and determine, at our sole discretion, that any portion or the entirety of the remaining balance is owed to you, we will notify you of the available methods to withdraw that remaining balance.

20. Severability

21.1 If any provision of these Terms and Conditions is found to be illegal, unlawful, or unenforceable, that provision shall be deemed severed from these Terms and Conditions. All other provisions shall remain in full force and effect, unaffected by the severance.

21. Assignment

21.1 Bet it All reserves the right to assign or otherwise lawfully transfer this agreement. The customer shall not assign or transfer this agreement in any manner.

22. Entire Agreement

23.1 These Terms and Conditions constitute the entire agreement between the customer and Bet it All regarding the use of the Website and/or App. Except in cases of fraud, these Terms and Conditions supersede all prior communications,

agreements, and understandings, whether electronic, written, or oral, between the customer and Bet it All concerning the Website and/or App.

23. Applicable Law

23.1 This Agreement and any issues arising from it shall be governed by and interpreted in accordance with the laws of Curaçao. You hereby irrevocably consent to the exclusive jurisdiction of the courts of Curaçao for any claims, disputes, or differences arising in connection with this Agreement. You also irrevocably waive any right you will have to contest the jurisdiction of those courts or to argue that the proceedings have been initiated in an inconvenient forum. This provision does not limit Bet it All's right to initiate proceedings against you in any other court of competent jurisdiction. Additionally, the initiation of legal action in one or more jurisdictions does not preclude the possibility of initiating proceedings in any other jurisdiction, whether simultaneously or otherwise, as permitted by the law of that jurisdiction.

24. Responsible Gaming/Gambling

24.1 For customers who wish to restrict their gambling activities, Bet it All offers a voluntary self-exclusion policy. This policy allows you to close your account or limit your ability to place bets or play games on the Website for a minimum period of one day. Once your account has been self-excluded, you will receive a confirmation email from security@betitall.bet. You will not be able to reactivate your account under any circumstances until the chosen self-exclusion period expires.

24.2. To initiate the self-exclusion process, please send a request to security@betitall.bet and ensure you receive a confirmation email in response. Be aware that emails will sometimes end up in your spam folder. If you do not receive confirmation from security@betitall.bet, please contact our Support Department for assistance. At the end of the self-exclusion period, you will resume use of the services by contacting security@betitall.bet.

24.3. When sending emails to support@betitall.bet or security@betitall.bet, ensure that your message is directly addressed and not forwarded or copied (cc) to avoid the risk of it being marked as spam. This is particularly important for matters related to account closure or gambling issues.

24.4. The week on Bet it All begins on Monday, and each day starts at 00:00 UTC. Every month starts on the first day of the month. Please consider this when setting your limits.

24.5. You acknowledge that there is a risk of losing both cryptocurrency and fiat currency while utilizing the Service, and Bet it All bears no responsibility for any such losses incurred.

24.6. You acknowledge that by engaging with the Services offered on the Website, you accept the risk of losing any deposited funds.

24.7 Guidelines for Responsible Gambling

If you are concerned about your gambling practices, consider the following guidelines:

- a) **Set Limits:** Establish limits on the amounts you wish to wager or deposit.
- b) **Time Management:** Decide how long you want your wagering session to last and monitor the time spent.
- c) **Balance Responsibilities:** Ensure that gambling does not interfere with your daily responsibilities.
- d) **Avoid Gambling Under Influence:** Refrain from gambling if you are recovering from any form of dependency or if you are under the influence of alcohol or any other substances, including certain prescription medications.

24.8 Important Considerations

- d) Keep track of the time and the amount spent on gambling.

- f) Bet it All is committed to supporting Responsible Gambling initiatives. We recommend visiting <u>www.responsiblegambling.org</u> for additional assistance if you feel that gambling is becoming a problem for you.

25. Disclaimer of Warranties
